### **MINUTES**

The undersigned, Assistant Secretary of the Springbrook Glen Homeowners Association, Inc., (the "Association") hereby certifies that at 7:00 p.m., December 6, 2007, the 2007 Annual Meeting of the Members was held at Pflugerville Justice Center, located at 1611 E. Pfennig Lane, Pflugerville, Texas.

#### Call to Order and Establish Quorum

The President of the Association, Paul Clutts, called the Annual Meeting of the Members to order at 7:08 p.m. The required number of members present for quorum was not met. In accordance with the Bylaws of the Association, the meeting was adjourned at 7:10, and notice was provided that the meeting would reconvene at 7:15 p.m.

#### Election of Directors

Paul Clutts called for additional nominations from the floor. There being none, he declared that nominations were closed. It was announced that the vote by secret ballot would commence. Members were asked if everyone had finished voting. There being no objection, the polls were declared closed, and the ballots were counted.

After the votes were tallied, the election results were announced. Socorro Valdez and Jeff Surber were elected.

Paul Clutts announced that the Board of Directors would meet immediately following the annual meeting to elect its officers for 2008.

There was no new business.


Open Forum
